





# President's Message

Our power is shown in our ability to achieve, our strength is shown in commitment, our actions are shown in what we do.



The 38th state, Virginia, said YES to Amendment 28, which means Amendment 28 should become part of the US Constitution!

It's fitting that Ruth Bader Ginsburg was announced cancer free and witnessed the passing of the ERA by the 38th State. Yet, even while we celebrate, three states (Alabama, Louisiana and South Dakota) filed injunctions to stop

addition of Amendment 28 to the US constitution. We in AAUW are joining others fighting these states. Let this the 100th anniversary of women's right to vote also be the year women are equal with men under the US constitution. Liz Jordan, co-President, AAUW-Sacramento will join us February 8 at the Edgewood Community Club house to update us on the latest. (See p. 1)

Year 2020 is a mixed and exciting year both nationally and locally. The required 38th State voted for Amendment 28, the EQUAL Rights Amendment. We are fighting states who say votes of the 38th state don't count. In March we vote in the primaries. In November we vote for President. At CHAR: It's been one year since we joined in partnership with the American River College and formed the AAUW @ ARC Student Club. Today we have 14 AAUW @ ARC Student Club members who join us in celebrating women. Erin Saberi's Blue Ribbon Commission is on track to provide the County Board of Supervisors a report explaining why Sacramento County needs a Commission for Women and Girls. (See p. 8). Days for Girls is on track to assemble up to 500 hygiene kits at the 2020 AAUW-CA convention for the United Nations High Commissioner for Refugees, Rwanda. (See p.5,6 for the donations needed) Tech Trek is on track to select five girls who will participate in the July STEM program at UC Davis and is on track to continue forming the Tech Trek Alumni group.

# ON ESTABLISHING A SACRAMENTO COUNTY WOMEN AND GIRLS COMMISSION

## **December 18 BRC meeting**

(Lee Battershell was in attendance representing AAUW-CHAR)

Community surveys and meetings with women and girls throughout Sacramento County revealed these top concerns:

- Safety/violence against women (59%)
- Housing/Homelessness (49%)
- Economic well-being (41%)
- Education (32%)
- Health/Reproductive care and education (30%)

To address these issues and identify other issues we formed five ad hoc committees and assigned BRC members to those committees:

- 1. Ad Hoc Committee on Assessing Need
  - Define the needs identified during the listening sessions.
- 2. Ad Hoc Committee on Resources
  - Identify all organizations currently serving Women & Girls in Sacramento County.
  - Create a matrix of issues being addressed and prioritized.
  - Identify known data of organizations serving women & girls in Sacramento County.
- 3. Ad Hoc Committee on Data & Information
  - Identify current data regarding women and girls known to county departments and agencies in cities within the county.
- 4. Ad Hoc Committee on Women's Commission Models
  - Review Women's commission models in California counties, other states, and internationally.
  - Document the structure, role, value, and responsibility of commissions.
- 5. Ad Hoc Committee on Youth
  - Review Youth concerns and support

# Blue Ribbon Commission meeting January 21, 2020

(PJ Missman and Roberta Schmalz were in attendance representing AAUW-CHAR)

The meeting was held at the Women's Empowerment facilities. There were 21 members present, not enough to establish a quorum, as there are 45 members on the commission.

Rick Heyer, a counsel for Sacramento County, gave a presentation on the Brown Act which requires local government meetings to be open to the public and open to public comments.

At the last meeting on 12/18, smaller work groups were formed. We all broke into our groups to establish leaders and work assignments. Our CHAR member will help gather information on existing services that are offered to women in our county. CHAR will be researching and uploading this data onto Google Worksheets. Charmen Goehring will be our group's leader. The Ad Hoc Advisory Committees that have been formed are:

- · Assessing Need
- Existing Resources
- Gathering Existing Data & Information
- · Women's Commission Models
- Youth Advisory

The important thing for us to do as a commission is to study what exists in our county and assess where the gaps are, in both services and needs. We will then pass this information on to the Sacramento County Board of Supervisors in order to enable the board to make an informed decision on whether or not to establish a Commission on Women and Girls in our county. This is extremely important work. If you want to attend a meeting, either to just learn about it all or to help with a work group, please let PJ Missman and/or Lee Battershell know.

The next meeting is February 19, 4-6pm at a location in District 3 (location TBD)

There are currently five Ombudsmen assigned to this program located in various parts of California. The primary function of the Ombudsman Program is to represent the interests of public safety for all Californians with a special interest in addressing the concerns of senior drivers. The Ombudsman can assist as a "go-between" to ensure that senior drivers are treated fairly, consistent with the laws and regulations, and with the dignity and respect they deserve. The Ombudsmen are available to assist in individual cases, as well as participate in outreach seminars for large and small audiences to promote driver safety in California with an emphasis on senior issues.


